Important points to be noted for this project:-

- Death Claims cases need to be covered in 2 hours from being reported.
- All completed forms (Signed and Stamped) need to be submitted on a weekly basis.
- Daily reports will be required.
- Approx quantity of Data for tagging 5 thousand per month.

<u>Contract Duration</u>: - Initial Contract duration is 1 year extendable up to 3 years, to be renewed annually on mutually acceptable terms.

<u>Coordination</u>: -Each vendor will be required to coordinate with the Owner and the Veterinarian Compounder of the District/Tehsil Tagging, Valuation and Certification will be done by the Veterinary Officer/Compounder.

Training: - Will be provided to 1-2 person per district in field.

<u>Cost to Owner</u>: - No fee to be collected from the owner of the Animals. In case, owner of animal for tagging or insurance neglects or, abstain from this procedure, then Insurance cover for the animal would be suspended.
